## Proposed fees for land title related products and services from 1 July 2010

The Land and Property Management Authority is officially registered in the Australian Business Register and also registered for GST. Its ABN is 33 537 762 019.

Land Property Information Division (LPI) intends to increase fees for land title related products and services from 1 July 2010. Increases will be in line with movement in the Consumer Price Index.

### What fees will change?

#### **When will the new fees take effect?**

The new fees will apply from 1 July 2010. Regulations relating to the new fees will be published in June 2010 on the NSW legislation website [www.legislation.nsw.gov.au](http://www.legislation.nsw.gov.au).

Current fees will continue to apply until 30 June 2010, and lodgments made before 1 July 2010 but not completed until after that date will be charged at 2009-10 rates.
